





Dear Ms. Porter:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to New York, New York, scheduled for December 17, 2012, sponsored by JNK Securities Corporation. Because it appears that some of the participants are attending in order to inform their trading activities in various securities, we remind you to avoid sharing non-public information in a manner that would implicate Federal law or regulations, or Rules or standards of the House of Representatives.

Committee rules require that you submit your complete pre-trip approval request to the Committee at least 14 days before the commencement of the trip. Despite your failure to do so in this instance, we are approving your current request. Any future requests should adhere to the 14-day requirement.

You must complete an Employee Travel Disclosure Form (which your employing Member must also sign) and file it with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are required to attach a copy of this letter and the Private Sponsor Travel Certification Form, including all attachments. You must also include a copy of the Traveler Form completed by you and signed by your employing Member. If you are required to file an annual Financial Disclosure Statement, you must also report all travel expenses totaling more than \$350 from a single source on Schedule VII of that statement.
