
Dear Colleague:


This is to notify you of Committee approval of your request of June 7, 2007 to teach a course for compensation at Georgetown University Law Center during the 2007-2008 academic year. Based on the information you provided with your request, we understand that these teaching arrangements are substantially the same as those for which the Committee has granted you approval in prior years. According to your letter, you have taught this course since 1991. As in recent years, you will be paid \$10,200 for teaching the class. In addition, you explain that no official resources will be used to meet your teaching obligation, nor do you believe that it will interfere or conflict with your congressional responsibilities. Furthermore, enclosed with your request was correspondence from the Dean of the Georgetown University Law Center stating that the teaching arrangements for the class you teach comply with the guidelines set forth by this Committee.

As noted in our prior correspondence, your teaching compensation is subject to the 15% outside earned income limit of House Rule 25, clause 1. For 2007, that limit is \$25,200. The income also must be reported on Schedule I of your annual Financial Disclosure Statement.

I am delighted that you have agreed to teach a seminar at the Law Center during the 2007-2008 academic year. This letter confirms the terms of your faculty appointment.

Consistent with Georgetown University's faculty leave policy, your leave of absence from the full-time faculty has been extended through June 30, 2008.

Your seminar will be offered as part of the regular J.D. program of instruction at the Law Center. Students will receive regular credit toward their law degrees for their attendance and participation in your seminar.

Your salary will be \$10,200, which will be paid out of Law Center operating funds. No federal funds will be devoted to your salary.
