This letter is to request that the following amendments be made to my Financial Disclosure Statements.

Liberty Road Properties:

2001-2003 House at 10399 Liberty Road Mt Pleasant value 100,000-250,000- delete from report.

2001 House at 10401 Liberty Road Mt Pleasant value 100,000-250,000-incorrect address. Change address to 10403 Liberty Road Mt. Pleasant.

2004 10399 Liberty Road was reported as sold for 250,000-500,000. Change address to 10403 Liberty Rd Mt Pleasant. Sale price was correctly reported. There were no capital gains.

2001-2007 add 1.27 acre lot that remained from purchase of 10403 Liberty Rd, valued at 15,000-50,000. Year end value has remained at 15,000-50,000. No income is generated from this property.

Big Woods property:

2004 House at 3444 big Woods Rd Frederick MD (Ijamsville) Change selling price to 250,000-500,000. There were no capital gains.

Knoxville Road Properties:

2000- Purchased house at 226 Knoxville Rd Knoxville MD valued at 15,000-50,000.

2000-2005 value of 226 Knoxville Rd increased to 100,000-250,000. No income produced.

2006 sold 226 Knoxville Rd for 250,000-500,000. There were no capital gains.

1999- purchased house at 230 Knoxville Rd value is 50,001-100,000

2001 sold house at 230 Knoxville Rd valued at 100,000-250,000. No capital gains.

2002-2006 Delete House at 230 Knoxville Rd valued at 50,001-100,000
