To Whom It May Concern:

This letter is to serve as an amendment to the Financial Disclosure Statements I filed for the years beginning in 2005 through 2010. This letter was prompted by your letter of June 16, 2011 seeking clarification as to the 2010 filing.

Upon review of the records, it was discovered that my husband, Sidney Williams was made part of a 401K plan back on September 1, 2005 by a prior employer Siebert Brandford Shank & Co., LLC, the amount of contributions for 2005 were \$1,961.54 and in 2006 \$5,076.94. These respective amounts should have been reported on the 2005 and 2006 years and the years thereafter. The total value of these have remained in the same category on the financial disclosure filings with a range of value between \$1,000-\$15,000 and are held in an open brokerage account (Cash Account) at Charles Schwab. There are no other investments that these funds are held in. The name was properly listed on Page 5 of the 2010 disclosure (abbreviated with the first two names of the firm); the firm is located at 1999 Harrison Street, Suite 2720, Oakland, CA 94612.

The other item brought into question in your letter was related to my husband's investment in American Golf Jt. Venture. In the past it has earned both Profit Sharing amounts and Interest, for the year 2010 it only disbursed Profit Sharing and no interest. It should be listed twice as it was.

Thank you for bringing these items to my attention. I trust that this answers all of your questions.
